ANVC 8(a) Sole Source Contracting

As an Alaska Native Village Corporation (ANVC), we offer a unique, flexible, and streamlined sole source procurement option to our Government customers. Sole source contracting with NHS provides the Government with Federal Acquisition Regulation (FAR) and Code of Federal Regulations (CFR) provisioned methods to maximize performance, mission continuity, and Small Business goal achievement.

Sole Source Advantages

- Significantly accelerated procurement timeline, without the disruptions and delays resulting from complex source selection evaluations and potential protests.
- Accuracy, flexibility, and reliability through open discussions prior to award (*per* 13 CFR 124.503), competitive threshold exemptions (*per* 48 CFR 19.805-1), and common management and administrative services.
- Elimination of pre-award schedule risk due to the non-challengeable nature of ANVC sole source procurements (*per 13 CFR 124.517*).

Why an Alaska Native Village Corporation?


- The ceiling for a sole source contract award to other 8(a) companies is limited to \$4.5M for non-manufacturing and \$6.5M for manufacturing contracts.
- Unlike other 8(a) companies, ANVCs provide the Government with a virtually unlimited sole source ceiling (*per 48 CFR 6.303-1*).
- The Government may award a sole source contract to an ANVC 8(a) company for up to \$22M without a Justification and Approval (J&A), and more than \$22M with a J&A, offering an unlimited threshold.
- The National Defense Authorization Act (NDAA) for Fiscal Year 2020 authorized Department of Defense Contracting Agencies to award an ANVC 8(a) sole source contract up to \$100M without a J&A (*Public Law No: 116-92*).

Accelerated Procurement Timeline

Measured in weeks rather than months, a sole source procurement provides the Government with NHS's expertise and demonstrated superb performance six times faster than a standard procurement. Since open discussions are authorized immediately following SBA approval, we can work directly with the client to ensure requirements and expectations are understood, tailored if necessary, and executed to the client's intent - No post award surprises.
